Wednesday, January 26th at 7:00 PM

William Cochran is a muralist, sculptor and designer. He and his partner, Teresa, work with government, private, and non-profit organizations to projects implement large-scale kinds. William recently completed permanent murals in Rockville, Maryland, and, Hershey, Pennsylvania, as well as a large-scale sculpture for Druid Hill Park in Baltimore in late 2010. In Rochester, New York, he is the design team artist with Bergmann Associates, helping facilitate the public process and design for an urban art trail that connects museums and engages the local citizens. The project was the highest rated in the state for TEP funds and won a major NEA grant. His well-known Community Bridge mural project draws thousands of visitors annually. He teaches painting in weeklong workshops several times a year, and often speaks at universities and conferences.
