# March Membership Meeting with Demo Artist Anne Gibson Snyder

Plein Air Painter

Wednesday, March 23rd at 3:00 PM

After teaching art at Frederick High School in Frederick, Maryland for two years, Anne opened the Catepetl Art Gallery, the first of its kind in the area. She received an Athena award from the Chamber of Commerce as business woman (owner) of the year. In 2000, Anne was given a one-person show at the Washington County Museum of Fine Arts. Her work was featured on the cover of the Outer Banks phone directory the same year. Anne received the Meredith Springer Award given by The Delaplaine Visual Arts and Education Center in June of 2005. The award recognizes accomplishments in the field of art as well as leadership in the Frederick Arts Community. Nine Artists: 25 Years included Anne's work along with eight other artists in November of 2006. The exhibition illustrated the emergence of art in Frederick County, Maryland from the early 1970's. This month long show held at The Delaplaine Visual Arts and Education Center featured a donorsupported, full color catalog. In September 2008 and 2010, Anne was one of 30 artists selected for the prestigious "Paint Annapolis" plein air painting event. Anne paints from life, often outdoors, necessitating inventive arrangements of bungee cords, old wooden ironing boards and other measures to accommodate wind and weather Anne Gibson Snyder continues to operate Catepetl Art Studio, providing professional art services to clients and corporations.
